**RE: Respect for the Rights of the Ejido La Sierrita and Workers of the Platosa Mine**

The International Network for Economic, Social and Cultural Rights (ESCR-Net) is the largest global network of organizations and activists devoted to achieving economic, social and environmental justice through human rights. Our membership is comprised of over 230 organizations and individuals from 67 countries.

We want to express our grave concern regarding the reported refusal of Excellon Mexico to participate in negotiations with the La Sierrita Ejido, alleged lack of compliance by Excellon with several previous agreements made with La Sierrita in 2008, and reported intimidation of people calling for dialogue. ESCR-Net has closely followed this case in recent years and has witnessed efforts by the Ejido La Sierrita and ProDESC to pursue peaceful means to attain a fair and equitable resolution to concerns regarding Excellon's operations.

According to reports received, Excellon has repeatedly declined to participate in negotiations convened by the Government regarding concerns expressed about the company's operations. We have been notified that Excellon is not complying with several clauses in the contract, including the construction of a water treatment plant and concessions for transportation of minerals and food services in the mine, and that exploration activities have occurred on Ejido land not covered in the temporary occupancy agreement, without prior consent. We are also concerned about reports that the representatives of Excellon have threatened to press legal charges against members of the Ejido and the Local 309 if they do not end their peaceful blockade to protest the continued operation of the mine until negotiations resume.

ESCR-Net wishes to remind you that the members of the Ejido and the local labor union have the right to assemble peacefully, free from repression or criminalization for their activities in defense of human rights. We recall that Excellon has an obligation to respect the human rights of communities affected by their operations, including the right to participation, information and other rights that facilitate their meaningful input into decisions that have impact on their lands and livelihoods. We further underscore the existence of domestic and international human rights standards, including the Constitution of Mexico, the Universal Declaration on Human Rights, the International Covenant on Civil and Political Rights, which protect the rights of people to peacefully assemble, and the United Nations Guiding Principles on Business and Human Rights, which encourage companies to engage in good faith efforts to promote dialogue and the peaceful resolution of disputes with affected communities .

We urge Excellon to respect the rights of the members of the La Sierrita Ejido to peacefully assemble and express their concerns. We call upon your company to enter in good faith into dialogue with the representatives of the Ejido and their partners, and do all in your power to ensure that the process is transparent, credible and inclusive, and promotes a peaceful, just and sustainable outcome to the present situation.

Finally, we request that you keep us informed of the measures taken to these ends.
