**Subject: Urgent Appeal to Halt Pathibhara  
Cable Car Project and Address Human Rights  
Concerns**

Dear Excellencies:

We write to you on behalf of ESCR-Net – International Network for Economic, Social and Cultural Rights, a global network of more than 300 non-governmental organizations, grassroots movements, human rights defenders, legal experts, and academics who work to promote and protect economic, social and environmental justice through human rights. We also write in solidarity with our fellow member, The Human Rights Awareness Center, who works tirelessly in support of the struggle of Indigenous Peoples and human rights across Nepal. We write to express our deep concern regarding the ongoing developments related to the Pathibhara cable car project in Taplejung district. The construction of the cable car has led to significant unrest among local communities, particularly the Indigenous Limbu People, who hold the Pathibhara area—referred to as Mukkumlung in their Mundhum tradition—as a sacred site.

The project's advancement raises **serious concerns** about potential violations of economic, social, and cultural rights, as well as environmental degradation due to deforestation. Moreover, the project has moved forward without securing the Free, Prior and Informed Consent (FPIC) of the Indigenous Limbu community, violating their right to self-determination and undermining their ability to protect their ancestral land.



On January 25, 2025, a confrontation between protesters and security personnel resulted in [injuries](#) to several individuals, including two protesters who sustained gunshot wounds. This incident underscores the escalating tensions and the urgent need for a peaceful resolution.

**In light of these developments, we respectfully urge the Government of Nepal to:**

- Immediately halt the construction of the Pathibhara cable car project to allow for comprehensive consultations with Indigenous Peoples, ensuring their free, prior, and informed consent (FPIC) in accordance with International Labour Organization (ILO) Convention No. 169<sup>1</sup> and United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) (Articles 10, 19, and 25)<sup>2</sup>, which the State of Nepal is obligated to uphold.
- Withdraw the heavy security presence deployed in the area to de-escalate tensions and foster a conducive environment for dialogue. The International Covenant on Civil and Political Rights (ICCPR) (Articles 6 and 21)<sup>3</sup>, to which Nepal is a State Party, guarantees the right to life and the right to peaceful assembly, both of which have been threatened by the militarized response to protests.
- Conduct an independent and transparent investigation into the events of January 25, 2025, ensuring accountability for the excessive use of force, in accordance with United Nations Basic Principles on the Use of Force and Firearms by Law Enforcement Officials (1990)<sup>4</sup>, which mandate that force may be used only when strictly necessary and must be proportional. The Convention Against Torture (CAT) (Article 12)<sup>5</sup>, ratified by Nepal, also requires prompt, impartial, and effective investigations into allegations of excessive force.
- Release individuals who have been reportedly falsely accused and/or unlawfully arrested in connection with the protests. The Universal Declaration of Human Rights

(UDHR) (Article 9)<sup>6</sup> and ICCPR (Article 9)<sup>7</sup> prohibit arbitrary arrest and detention, emphasizing the need for due process and humane treatment of detainees.

We emphasize that Nepal, as a party to the above international treaties, has a legal and moral obligation to respect, protect, and fulfill human rights. The ongoing violence and displacement caused by the Pathibhara cable car project not only contravene these obligations but also set a bad precedent for Indigenous rights and environmental justice in the country.

We urge your government to take immediate action to address these concerns and engage in a genuine dialogue with the Limbu People and other affected communities to ensure that development projects do not come at the cost of human rights.

We appreciate your prompt attention to this matter and look forward to your response.
